Literacy Goal

By the end of this school year, we will improve student mastery of rigorous learning standards in Reading/ELA as measured by: (1) Increase by 5% the number of students achieving proficient or distinguished on ELA Georgia Milestones End of the Grade Assessments, (2) Increase by 5% the number of students meeting or exceeding mean expected growth projection for MAP reading scores, and (3) Increase in percent of Exceptional Learners with positive movement on standardized assessments.

Math Goal

By the end of this school year, we will improve student mastery of rigorous learning standards in mathematics as measured by: (1) Increase by 5% the number of students achieving proficient or distinguished on Math Georgia Milestones End of Grade Assessments and (2) Increase by 5% the number of students meeting or exceeding mean expected growth projection for MAP math scores.

JOINTLY DEVELOPED

Oak View Elementary School will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

The Parental Involvement Policy is reviewed and revised at least annually during the Title I Planning Meeting Parents actively participate in the development of the Policy, working jointly with teachers, administrators, and the Title I Parent Liaison. Parents were given a "draft" copy of the policy, the School-Parent Compact, and the Family Engagement Calendar of Events to review what the documents currently look like. Parents work in small groups and are given the opportunity to suggest any changes or additions to the documents. Parents are provided a feedback form to suggest revisions to the Title I documents. Suggestions for revisions are welcome throughout the school year during parent-teacher conferences, phone communication, emails, and at all school meetings. Parents give feedback after every parent workshop that is conducted, e.g. literacy, math, technology, etc.

Additionally, parents can continue to participate in the decision-making process regarding their child's education by communicating their suggestions via email and PTA meetings. All feedback forms from the Title I Planning meeting are submitted to the Title I Parent Liaison for review. The Parent Liaison, Mrs. Jackson, serves as a link between parents and teachers to convey suggestions and concerns to administration on an ongoing basis.

ANNUAL TITLE I MEETING

Oak View ES will provide parents and students support in transitioning to kindergarten by holding a Kindergarten Transition meeting in May 2018. Flyers will be sent to neighboring day care centers and Head Start. At this meeting, Head Start parents will meet with current kindergarten teachers and receive information about kindergarten expectations, curriculum, and standards. Academic activities will be shared to be conducted at home. Parents will be introduced to the Parent Center and the resources available there.

CAPACITY OF SCHOOL STAFF

<u>Oak View Elementary School</u> will provide training to educate the teachers, pupil services personnel, principal, and other staff in how to reach out to, communicate, and work with parents as equal partners, in the value and utility of contributions of parents and in how to implement and coordinate parent programs and build ties between parents and the school by:

Oak View ES will provide training for teachers and staff on effective communication strategies and how to work with parents as equal partners by using research-based articles, TIP sheets and PowerPoint/videos. The topics are to include the do's and dont's in communicating with parents and the importance of having parents as partners in the education of their children.

Faculty and staff meetings will include strategies for working with parents throughout the year, especially before parent/teacher conferences are held. Parents and representatives from the PTA may occasionally visit faculty/staff meetings to make brief presentations, offer tips to effective parent-teacher interactions, and communicate ideas for improving the parent-teacher partnership. Additional trainings and workshops may be arranged according to the feedback we receive from parents.
